
UVI YEAR OVER YEAR (YOY) OPERATING REVENUES & EXPENDITURES




4. DEVELOPMENT

- -Approximately 1% of all giving comes from Alumni body -Less than 1% of all giving comes from Boards and Cabinet
 - -90% of giving comes from RT Park/ EDC/ Local industry
 - -63% of all gifts are directed to the UVI Foundation for distribution across campus
 - -Development (two gift officers and VPIA) must focus on \$50K+ donors and prospects
